Columbiana Hi Tech Front End, LLC requests that the certificates of compliance listed below currently issued to Eco-Pak Specialty Packaging (a Division of the Columbiana Boiler Company) be issued to Columbiana Hi Tech Front End, LLC. Due to a re-organization of the Columbiana Boiler Company, the name of the nuclear division has been changed from Eco-Pak Specialty Packaging to Columbiana Hi Tech Front End, LLC.
