SUBJECT: Clarification of Omaha Public Power District's Response to Commission Order to Modify License for Interim Safeguards and Security Measures

In accordance with 10 C.F.R. 50.4, Omaha Public Power District (OPPD) hereby submits the safeguards-related information as clarification concerning OPPD's March 15, 2002 response (Reference 3) to the Interim Safeguards and Security Compensatory Measures Order (hereinafter "Order") issued by the United States Nuclear Regulatory Commission (NRC) on February 25, 2002 (Reference 2). This information is being submitted in response to a telecon with the NRC dated April 11, 2002. This submittal supersedes and clarifies the information provided in Reference 3 with respect to OPPD's response to Order Requirements B.1.a, B.2.a(2), B.5.b, B.5.d, and B.5.e. This submittal does not alter the information provided in OPPD's March 15, 2002 Answer to the Order (Reference 4) with the exception that OPPD withdraws its request for an extension of time to answer Order Requirement B.2.a(2). The attachment to this correspondence contains "Safeguards Information", as defined in 10 CFR 73.21. OPPD therefore requests that the attachment be withheld from public disclosure.
