Dear Mr. Cavanaugh:

On November 13, 1978, the Commission issued Amendments Nos. 37 and 5 to Facility Operating Licenses Nos. DPR-51 and NPF-6 for Arkansas Nuclear One, Units Nos. 1 and 2 (ANO-1 & 2), respectively.

These amendments modified the Technical Specifications dealing with the plant organization structure and revised the ANO-1 Administrative Controls of the Environmental Technical Specifications to make them current and consistent with ANO-2. However, the position of "Manager of Nuclear Operations" was inadvertently omitted from Figure No. 5-1, "Environmental Surveillance Organization Chart," of the Environmental Technical Specifications for ANO-1 & 2.

We have corrected this error and have enclosed revised pages for insertion in your Technical Specifications.




