  - (a) The total estimated amount of this contract ceiling for the basic contract through Option Year 2 is \$1,146,043.00, which includes the basic contract (\$364,400), Option Year 1 (\$384,620), and Option Year 2 (\$397,023). The contracting officer may unilaterally increase this amount as necessary for orders to be placed with the contractor during the contract period provided such orders are within any maximum ordering limitation prescribed under this contract.
- 3. Under Section F <u>Deliveries or Performance</u>, Paragraph, F.5 <u>Duration of Contract Period</u> is hereby deleted in its entirety and substituted in lieu thereof the following:
  - "F.5 <u>Duration of Contract Period (MAR 1987)</u>, Alternate 4 (JUN 1988)

This contract shall commence on April 1, 2000 and will expire on March 31, 2003. The term of this contract may be extended at the option of the Government for one additional one-year option."

All other terms and conditions remain unchanged.
