While it is allowable, please refrain from submitting proprietary information in support of a registration unless necessary. Keep in mind that all registration certificates in the Sealed Source and Device Registry, and all NRC licenses are considered to be in the public domain, and are therefore may be viewed by any member of the public who requests to see them.

Please submit the requested information within thirty days of the date of this letter. If we have not received complete information within thirty days of the date of this letter, we will consider your application as having been abandoned by you. This is without prejudice to the resubmission of a complete application
