SUBJECT: INCORRECT NRC LICENSE

Dear Mr. Crihan:

In our letter to you dated May 18, 2001 (enclosed) concerning our May 7, 2001 inspection, we informed you that if you did not obtain or use licensed materials authorized by your license by June 17, 2001, you must provide notification in accordance with 10 CFR 30.36(d)(3). 10 CFR 30.36(d)(3) requires that you notify the Commission in writing when no principal activities have been conducted under the license for a period of 24 months. We have not received notification as required. Please submit the notification required by 10 CFR 30.36(d)(3).

The mailing address on your license (item 2) and the storage location on your license (condition 11.A) list a Niantic, Connecticut address which is not accurate since you no longer occupy the Niantic, Connecticut facility. A recent request to amend your license to change your storage location from Niantic, Connecticut to Trainer, Pennsylvania was voided because you failed to provide necessary information as discussed in our letter to you dated March 26, 2002 (enclosed). It is our understanding that you no longer have a location in a State where the NRC maintains jurisdiction for regulating licensed material, and that your office (mailing address) is currently in New York City. It appears that you no longer have a mailing address and/or a storage location in a State where the NRC maintains jurisdiction for regulating licensed material. Therefore, you must take action to correct or terminate your license, as discussed below:

1. Request that your license be amended to change your mailing address to a location that you occupy (New York City) or a P. O. Box; delete the location in Niantic, Connecticut. Since your license authorizes temporary job sites in States where NRC maintains jurisdiction for regulating licensed material, you may store the licensed material in the Agreement State and transport in to the place of use in an area regulated by the NRC. However, this requires that you have a license for possession of byproduct material in the Agreement State.
2. Use an Agreement State license if you plan on working in States under NRC jurisdiction for less than 180 days a year. You may then apply for reciprocity to use radioactive

materials in States where the NRC maintains jurisdiction for regulating licensed material.
(See 10 CFR 150)

3. Terminate your NRC license. You may reapply for an NRC license at any future date when you anticipate that licensed operations with byproduct material are imminent; and when you have a mailing address and/or storage location in a State where the NRC maintains jurisdiction for regulating licensed material. You must complete the enclosed form 314 and return it to us in order to terminate your license.

Please provide a reply requesting the appropriate change within seven (7) days of receipt of the letter. If you do not respond to this letter, we will consider appropriate enforcement action, including the modification or termination of you license.
