COMPOSITION

6.5.1.2 The PSRC shall be composed of the:

Chairman:	Manager, Plant Support
Vice Chairman/Member:	Manager, Plant Operations
Member:	Manager, Plant Maintenance
Member:	Operations Superintendent
Member:	Manager, Performance and System Engineering
Member:	Manager, Quality Services
Member:	Chemistry/Radiation Control Superintendent
Member:	I&C Superintendent
Member:	Plant Licensing Superintendent

ALTERNATES

6.5.1.3 All alternate members shall be appointed in writing by the GGNS General Manager to serve on a temporary basis; however, no more than two alternates shall participate as voting members in PSRC activities at any one time.

MEETING FREQUENCY

6.5.1.4 The PSRC shall meet at least once per calendar month and as convened by the PSRC Chairman or Vice Chairman.

QUORUM

6.5.1.5 The quorum of the PSRC necessary for the performance of the PSRC responsibility and authority provisions of these Technical Specifications shall consist of the Chairman or Vice Chairman and four members including alternates.

RESPONSIBILITIES

6.5.1.6 The PSRC shall be responsible for review of:

- a. Station administrative procedures and changes thereto.
- b. The safety evaluations for (1) procedures, (2) changes to procedures, equipment or systems, and (3) tests or experiments completed under the provision of Section 50.59, 10 CFR, to verify that such actions did not constitute an unreviewed safety question and all programs required by Specification 6.8 and changes thereto.
- c. Proposed procedures and changes to procedures, equipment or systems which may involve an unreviewed safety question as defined in Section 50.59, 10 CFR.
- d. Proposed tests or experiments which may involve an unreviewed safety question as defined in Section 50.59, 10 CFR.
- e. Proposed changes to Technical Specifications or the Operating License.

1.0 INTRODUCTION

By letter dated July 15, 1988, System Energy Resources, Inc. (the licensee), requested an amendment to Facility Operating License No. NPF-29 for the Grand Gulf Nuclear Station, Unit 1. The proposed amendment would change the Technical Specifications by changing the position of one of the nine members on the Plant Safety Review Committee (PSRC) from Technical Superintendent to Manager, Performance and System Engineering.

2.0 EVALUATION

The proposed amendment is needed because of a change in the Grand Gulf Nuclear Station (GGNS), Unit 1, operating organization. The engineering personnel in the Technical Support Group, the Plant Modification and Construction Group, and the Maintenance Group were consolidated in a new Performance and System Engineering Department (P&SE) and the position of Technical Support Superintendent was eliminated.

The Manager, P&SE, will be responsible for management of activities necessary to support operation of GGNS, Unit 1, including system engineering, inservice inspection, reactor engineering, and engineering support of maintenance and operations. The Manager, P&SE will report to the GGNS General Manager. The Technical Support Superintendent was responsible for essentially the same activities and reported to the Manager, Plant Support, who reported to the GGNS General Manager.

The staff has reviewed the proposed change in membership on the PSRC and concludes that the change is acceptable because the Manager, Plant Systems and Engineering has essentially the same level of expertise and management responsibility as the Technical Support Superintendent had in the previous organization. Accordingly, the effectiveness of the PSRC will not be adversely affected by the change.

3.0 ENVIRONMENTAL CONSIDERATION

This amendment relates to changes in recordkeeping, or administrative procedures or requirements. Accordingly, the amendment meets the eligibility criteria for categorical exclusion set forth in 10 CFR 51.22(c)(10). Pursuant to 10 CFR 51.22(b), no environmental impact statement or environmental assessment need be prepared in connection with the issuance of this amendment.

4.0 CONCLUSION

The Commission made a proposed determination that this amendment involves no significant hazards consideration, which was published in the <u>Federal</u> <u>Register</u> (53 FR 30139) on August 10, 1988, and consulted with the State of Mississippi. No public comments or requests for hearing were received, and the State of Mississppi did not have any comments.

The staff has concluded, based on the considerations discussed above, that: (1) there is reasonable assurance that the health and safety of the public will not be endangered by operation in the proposed manner, and (2) such activities will be conducted in compliance with the Commission's regulations and the issuance of this amendment will not be inimical to the common defense and the security, or to the health and safety of the public.
