Dear Ms. Gibson:

I am writing to request Potassium Iodide for use by the general population in Ohio that is in the 10 mile emergency planning zone (EPZ) for the following nuclear power plants:

1. Beaver Valley Nuclear Power Plant--The population in the 10-mile Emergency planning zone Ohio is responsible for is in Columbiana County Ohio and the city of East Liverpool, Ohio. The base residential population is 12,850. The population associated with schools is 2,400. The population associated with transient population is 5,000. The population associated with employers is 1,000. The total population requested for the Ohio portion of the Beaver Valley EPZ is 21,250.
2. Perry Nuclear Power Plant--The population Ohio is responsible for is in Lake County, Geauga County, and Ashtabula County. The base residential population is 82,100. The population associated with schools is 17,700. The population associated with transients is 100,000. The population associated with employers is 1,000. The total population requested for the Perry EPZ is 200,800.
3. Davis-Besse Nuclear Power Station--The population Ohio is responsible for is in Ottawa County and Lucas County. The base residential population is 23,000. The population associated with schools is 5,500. The population associated with transients is 65,000. The population associated with employers is 3,500. The total population requested for the Davis-Besse EPZ is 97,000.
4. The total population request for the State of Ohio for Potassium Iodide is 319,500.

Based on the information provided by NRC, we understand that the Potassium Iodide requested will be delivered to Ohio within the next forty-five days.
