NRC has reviewed the Center's Administrative Procedure AP-012, Authorization to Conduct Federally Funded Research and Development Work-For-Others" and offer the following comments:

Page 3, first paragraph, last sentence, suggest deleting the words ..."as specified by **contracts between NRC and the CNWRA.**" Note: Section C.1.1.2 and other contract provisions do not specify verbatim, all of these together.

Page 5, Section 4.5, first sentence, delete "**NRC CNWRA Review Group**" and substitute the words "**Work-For-Others Committee.**" Note: The NRC CNWRA Review Group has different voting members and does not get involved in the work-for-others review. The Work-For-Others Committee is currently comprised of the NRC Center Program Manager (J. Linehan), the NRC Deputy Program Manager (D. DeMarco), the NRC Center Contracting Officer (B. Meehan) and the NRC Center Senior Attorney (R. Baum).
