I needed to confirm my understanding on this matter with my management, which I have now done.

DFS, a subcontractor for a DOE prime contractor, does not require an NRC license to use a portable moisture density gauge for activities that are conducted <u>only</u> at Oak Ridge, a DOE site. The basis for this position is that through its contracts with its prime contractor, DOE has the authority (and responsibility) to exercise safety oversight; therefore, it is not necessary to exert additional control by also requiring DFS to become an NRC licensee.
