On November 10, 1975 we issued Amendments 12 and 10 to the Operating Licenses for Peach Bottom Units 2 and 3, respectively. These amendments, which incorporated revised administrative controls in the Technical Specifications as Changes Nos. 13 and 10 for Peach Bottom Units 2 and 3, respectively, were to be effective 30 days from the date of issuance.

### Introduction

By application for License Amendment dated December 4, 1975, the Law Offices of Conner, Hadlock, and Knotts requested that the effective date for License Amendments Nos. 12 and 10, which we issued for Peach Bottom Units 2 and 3 on November 10, 1975, be extended from December 10, 1975 to January 1, 1976.

#### Evaluation

License Amendments Nos. 12 and 10 provided modified administrative controls, Section 6.0 of the Radiological Technical Specifications, for operation of Peach Bottom Units 2 and 3. We also determined that Amendments Nos. 12 and 10 did not involve a significant hazards consideration. The extension of the date of effectiveness for License Amendments Nos. 12 and 10 will not affect plant safety since sufficient administrative controls will be in effect during the period of December 10, 1975 to January 1, 1976.

#### Conclusion

We have concluded, based on the considerations discussed above, that:
(1) because the change does not involve a significant increase in the probability or consequences of accidents previously considered and does not involve a significant decrease in a safety margin, the change does not involve a significant hazards consideration, (2) there is reasonable assurance that the health and safety of the public will not be endangered by operation in the proposed manner, and (3) such activities will be conducted in compliance with the Commission's regulations and the issuance of these amendments will not be inimical to the common defense and security or to the health and safety of the public.
