The purpose of the meetings was to gather information necessary to complete the renewal review and to familiarize NRC staff with the facility. The NRC review team participated in a site tour and held meetings with the appropriate individuals to discuss technical issues. The first draft of the renewal Safety Evaluation Report is scheduled to be completed by August 2002.

The technical areas which were reviewed include environmental monitoring, radiation protection, emergency preparedness, chemical process safety, fire safety, configuration management, corrective action program, and training. A separate visit will be scheduled in the next few months to have the NRC nuclear criticality reviewer tour the site. Framatome will plan to submit a revised application, based on discussions, after the next site visit.
