On May 15, 2002, Entergy Nuclear Operations, Inc. (ENO) submitted a supplemental response to the Interim Safeguards and Security Compensatory Measures Order (Order, Reference 1) issued by the United States Nuclear Regulatory Commission (NRC) on February 25, 2002. As a result of telephone discussions with the NRC staff, ENO is clarifying its prior response (Reference 2).

Pursuant to the requirements of 10 CFR § 50.4 the attachment to this letter contains Entergy's supplemental response to Section B.4.e of the Order. This response supercedes and replaces the response submitted with Reference 2 for Section B.4.e. The attached response also identifies the current schedule dates for completion of the Order requirements based upon the latest available information. As required by the Order the actions to implement the Order have been started and unless relief has been requested all of the actions will be completed no later than August 31, 2002. Attachment 1 to this response contains safeguards information, as defined in 10 CFR § 73.21. Entergy therefore requests that this attachment be withheld from public disclosure.

## SAFEGUARDS INFORMATION


