On March 15, 2002, Entergy submitted its response to the Interim Safeguards and Security Compensatory Measures Order ("Order") issued by the NRC on February 25, 2002. We indicated in the response that additional time was necessary to complete analyses with respect to Interim Compensatory Measures (ICM) B.2.a.(1), B.2.a.(2) and B.2.b. before a schedule for achieving compliance with those requirements could be submitted. This was in accordance with Section III.C.1. of the Order. The analyses, with respect to the remainder of those ICMs, have been performed and Entergy is providing the required compliance schedule. In accordance with 10 CFR § 50.4, Entergy hereby submits its supplemental response to the Order. Attachment 1 to this response contains safeguards information, as defined in 10 CFR § 73.21. Entergy therefore requests that this attachment be withheld from public disclosure.
