The purpose of this modification is to:

- (1) extend the maintenance of Current Operations during the task order first year. This extension is necessary to accommodate infrastructure design validation. As a result, Section Schedule A-1 YEAR 1 (BASE) of the Task Order is revised to reflect the additional months of maintaining Current Operations and the reduction of months of IT Infrastructure Operations as shown in Attachment 1 to this modification and EER Systems's proposal, dated 1/22/2002 with revisions dated 1/29/2002, 1/30/2002, and 2/05/2002;
- (2) revise Subsection B.8 CONSIDERATION AND OBLIGATION, by increasing the total estimated task order amount. This increase is associated with the additional months of maintaining Current Operations and the reduction of months associated with IT Infrastructure Operations. by \$90,065.69 from \$25,542,273 to \$25,632,338.69
- (3) revise Subsection F.7 Delivery Schedule and Milestone Dates, by extending the planned delivery dates for: Subtask 1-3: Maintain Current Operations from 1/28/2002 to **03/31/2002**; and Task 2 Transition (Optional) from 1/28/2002 to 4/1/2002.

This modification confirms: the NRC PO's e-mail message dated 12/21/01, in which EER was notified of the NRC's intent to extend the requirement to maintain current operations; the Contracting Officer's verbal notification to continue operations provided on 01/25/02; and also confirms the Contracting Officer's authorization to continue maintaining current operations provided to Ms. Joanne Newman of EER Systems by e-mail message on 2/11/02.

Accordingly, the following section of the task order is hereby modified:

1. under Schedule A-1 YEAR 1 (BASE) is revised by increasing the quantity of months order under CLINs 0001C, subtask 1-3 Maintain Current Operations from 3 and 1/2 months to 5 and 1/2 months, and reducing the quantity of months order under CLIN - 0003AB, IT Infrastructure Operations from 8.5 months to 6.5 months. (See the attached revised Schedule A-1.)
2. Under Subsection B.8 CONSIDERATION AND OBLIGATION, the first sentence of paragraph (b) is deleted entirely and the following is substituted in-lieu thereof:  
  
"(a) The total estimated amount of this task order (ceiling) for the products/services ordered, delivered, and accepted under this task order is \$25,632,338.69."
