### LICENSEE: Exelon Generation Company, LLC

- FACILITIES: Dresden, Units 2 and 3 Quad Cities, Units 1 and 2
- SUBJECT: SUMMARY OF MEETING TO DISCUSS PLANNED LICENSE RENEWAL APPLICATION

On May 20, 2002, representatives of Exelon Generation Company, LLC (Exelon) met with the Nuclear Regulatory Commission (NRC) staff to discuss submittal of combined license renewal applications for Dresden, Units 2 and 3, and Quad Cities, Units 1 and 2. Exelon is scheduled to submit the application on January 3, 2003. Attendees at the meeting are listed in Attachment 1. The agenda for the meeting is contained in Attachment 2.

Using Attachment 3, Exelon described its organization and the approach being used to prepare the application. Details were provided regarding the format and content of the application. Attachment 4 provided examples of application material illustrating Exelon's planned approach as described in Attachment 3.

Exelon plans a single submittal for both plants addressing 10 CFR Part 54 safety requirements, which will identify any differences between the plants. Separate supplements to the updated final safety analysis reports for Dresden and Quad Cities will be provided. Because two different plant sites are involved, separate environmental reports will be needed to meet the requirements of 10 CFR Part 51.

The format and content of the safety evaluation portion of the application will follow the latest guidance contained in NUREG-1800, "Standard Review Plan for Review of License Renewal Applications for Nuclear Power Plants;" NUREG-1801, "Generic Aging Lessons Learned (GALL) Report;" and Regulatory Guide 1.188, "Standard Format and Content for Applications to Renew Nuclear Power Plant Operating Licenses;" that endorsed Nuclear Energy Institute (NEI) guidance document NEI 95-10, Revision 3, "Industry Guidance for Implementing the Requirements of 10 CFR Part 54 — The License Renewal Rule." Lessons learned from Exelon's preparation and review of the Peach Bottom renewal application will be incorporated as well as early lessons learned from the Fort Calhoun renewal review which is the first application to fully utilize the latest guidance documents. The submittal will also reflect current industry positions at the time of application on interim staff guidance issued by the NRC.

Exelon plans to provide copies of the application in electronic form on CD-ROMs which will include the UFSAR. A separate CD-ROM will be provided with only the application which will be formatted to facilitate the staff's placing it on the license renewal website.
