BECHTEL SAIC COMPANY, LLC (BSC) QUALITY ASSURANCE (QA) SURVEILLANCE REPORT BSCQA-02-S-09 OF VERIFICATION OF CORRECTIVE ACTIONS FOR CAR BSC-02-C-001

Enclosed is the Surveillance Report BSCQA-02-S-09, conducted by the BSC QA Organization on May 20-30, 2002, at the BSC facilities in Las Vegas, Nevada.

The scope of the surveillance was to verify implementation of BSC corrective actions committed to in response to Corrective Action Report (CAR) BSC-02-C-001. The surveillance determined that not all corrective actions committed to have been implemented, therefore, CAR BSC-02-C-001 is not ready to be closed at this time.

The surveillance identified two concerns relative to multiple, inconsistent subcontractor databases within the BSC Procurement organization and lack of clarity concerning identification of Functional Managers. These concerns are documented in CIRS #2708 and Document Action Request (DAR) D4271, respectively.

 BSC QA conducted this surveillance to verify corrective actions committed to by BSC in the 05/01/2002 response to CAR BSC QA conducted this surveillance to verify corrective actions were investigated to assess if the corrective actions were implemented: a) Exhibit B to the Technical Professional Services Subcontract has been modified to incorporate and highlight requirements to ensure that subcontractor personnel are appropriately trained. Verification Result - Subcontracts reviewed during the surveillance have been modified to incorporate and highlight training requirements as stated in the CAR response. Subcontracts of contractors who were previously Project teammates under former contractor TRW (i.e., Framatome, IBEX Group Inc. and Science Engineering Associates, Inc.) were modified during this surveillance to include an Exhibit B addressing training requirements. b) A revised Statement of Work (SOW) has been appended to all staff augmentation subcontracts. verification Result - Subcontracts reviewed during this surveillance were modified to include a revised acceptable SOW. c) The SOW references personnel qualification and reporting requirements contained in Exhibit B to the Technical Professional Services Subcontract.  10. Surveillance Conclusions SAT UNSAT The CAR cannot be closed at this time. There is no objective evidence of implementation of the revised LP-4.3Q requiring Procurement to provide Functional Managers with a monthly listing of subcontractor personnel performing quality affecting work. The requirement has been in effect for two months. Two concerns were raised by the Surveillance Team while trying to verify committed corrective actions: a) There are multiple inconsistent databases within the Procurement organization that identify subcontractors, functional managers, and personnel associated with them. Refer to CIRS Item No. 2708. b) LP-1.0Q-BSC, Organization is not clear and appears to cause confusion among personnel as to who is a Functional Manager, thereby adding to differing procurement databases. BLOCK 7. Description/Details (Continued):

d) Two procurement procedures LP-4.3Q-BSC Subcontracts and LP-4.4Q-BSC Technical Service Agreements, were revised effective 03/18/2002. Included among the revisions are provisions requiring reports to ensure subcontractor employees are identified, ensuring subcontractor employees are assigned appropriate training, and providing feedback on changes affecting an individual's training status.

Verification Results - The procedures, LP-4.3Q-BSC, Revision 0, ICN 2, and LP-4.4Q-BSC, Revision 0, ICN 2, were revised as committed, however, there is no objective evidence of implementation of the revised LP-4.3Q requiring Procurement to provide Functional Managers with a monthly listing of subcontractor personnel performing quality affecting work.

Two concerns were raised by the Surveillance Team while trying to verify item d) above. As a result, item a) below has been entered into the CIRS System as Item number 2708. Item b) below has had a Document Action Request (DAR) generated to address this concern (DAR number D4271).

a) There are multiple inconsistent databases within the Procurement organization that identify subcontractors, personnel associated with them, and what personnel are identified as Functional Managers.

b) There appears to be some confusion as to who is a Functional Manager. The definition in LP-1.0Q-BSC, Organization is not clear. Section 3.2 is inconsistent with Attachment 2 of the procedure. The QA Manager and ES&H Manager are identified as Functional Managers on Attachment 2, but they are not identified in the definition in Section 3.2.
