SUBJECT: SUMMARY OF MAY 30, 2002, ANNUAL ASSESSMENT MEETING WITH
ENTERGY NUCLEAR OPERATIONS, INC.

On May 30, 2002 at 3:00 p.m., a regulatory performance meeting was conducted at the Verplanck Fire House in Verplanck, NY between the Nuclear Regulatory Commission (NRC) staff and Entergy Nuclear Operations, Inc. (ENO). The purpose of the meeting was for the ENO to describe the current status of improving performance at Indian Point Unit 2 (IP2).

The meeting was opened by Brian Holian, Deputy Division Director, Division of Reactor Projects, who introduced the staff and initiated the NRC presentation. The Regional Administrator also participated in the meeting. The NRC briefly summarized previous assessments and described the next steps in monitoring and assessing IP2, a multiple degraded cornerstone plant. During their presentation, Entergy described their progress in improving plant performance through their fundamentals improvement plan (FIP), including a description of station wide initiatives that are underway. During the meeting, the NRC questioned Entergy on their presentation. Approximately 75 people attended the meeting.

At the end of the meeting between Entergy and NRC, public attendees were offered the opportunity to ask questions of NRC officials. Numerous questions were asked over a two hour period. The following issues were discussed: the timing and adequacy of performance improvement efforts, plant technical issues, offsite releases, the Riverkeeper 2.206 petition, open condition reports in the corrective action program, design basis verification, basis for extending the integrated leak rate test of containment, Davis Besse reactor vessel head issues, plant security issues, and evacuation issues within the local communities. These questions and comments were addressed by NRC management.
