By letter dated April 15, 1986, Louisiana Power and Light Company withdrew a portion of its December 2, 1985 application for an amendment to Facility Operating License No. NPF-38 for the Waterford Steam Electric Station, Unit No. 3. 
LOUISIANA POWER AND LIGHT COMPANY
WITHDRAWAL OF APPLICATION FOR AMENDMENT
TO FACILITY OPERATING LICENSE
DOCKET NO. 50-382

The United States Nuclear Regulatory Commission (The Commission) has granted the request of Louisiana Power and Light Company (the licensee) to withdraw a portion of its December 2, 1985 application for a proposed amendment to Facility Operating License No. NPF-38, which authorizes operation of the Waterford Steam Electric Station, Unit No. 3 located in St. Charles Parish, Louisiana. The proposed amendment would have changed a reference in Administrative Control 6.4.1 of the Technical Specifications from Section 5.2 of ANSI 3.1-1978 to Section 5.5 of the same ANSI Standard. The Commission issued a Notice of Consideration of Issuance of Amendment in the Federal Register on January 29, 1986 (51 FR 3715). By letter dated April 15, 1986, the licensee withdrew this portion of its application for the proposed amendment. The Commission has considered the licensee's April 15, 1986 letter and has determined that permission to withdraw this portion of the December 2, 1985 application for amendment should be granted.
