SUBJECT: REQUESTS THAT THE NRC HOLD HEARINGS

On April 22, 2002, the notice providing an opportunity to request a hearing within 30 days with respect Pacific Gas and Electric Company's application for the establishment of an Independent Spent Fuel Storage Facility on the Diablo Canyon Plant site was published in the Federal Register. During the thirty day period, the attached correspondence was received requesting that the NRC hold hearings on the application. The correspondence was respectively submitted by Pat and Fred Frank on April 27, 2002, Jeanne McIntosh on May 9, 2002, Mike Anderson on May 16, 2002 and Carolyn Moffatt, representing the Port San Luis Harbor Commission on May 20, 2002. 
Honorable Chair of the U. S. Nuclear Regulatory Commission:
