Subject: Request for Suspension of Review of 10CFR50.55a Requests for Alternative for the
Davis-Besse Nuclear Power Station, Unit 1 Reactor Pressure Vessel Head Repair (RR-
A23, RR-A24, and RR-A25)

Ladies and Gentlemen:

The purpose of this letter is to request suspension of the NRC Staff's review of 10CFR50.55a requests RR-A23, RR-A24, and RR-A25 related to repair of the Davis-Besse Nuclear Power Station (DBNPS), Unit 1 reactor pressure vessel head that were transmitted by FirstEnergy Nuclear Operating Company (FENOC) letters Serial Number 2783 and Serial Number 2785, both dated April 25, 2002. On May 23, 2002, FENOC notified the NRC Staff that it had purchased the unused Midland Nuclear Plant reactor pressure vessel head, and that the replacement of the head was the preferred option for returning the DBNPS to service. Therefore, the repair of the Reactor Pressure Vessel Head is no longer being actively pursued as part of the as the primary option. However, since the repair option could potentially still be considered in the future depending on various factors, the NRC Staff's review of 10CFR50.55a requests RR-A23, RR-A24, and RR-A25 is only requested to be suspended at this time. FENOC will notify the NRC Staff in the future of any changes in this status.
