As you know, the Licensing Board issued an Order today setting schedules for responses to the June 11 and June 12 requests to stay the NRC ISFSI proceeding. Counsel for PG&E only became aware of the stay requests as a result of the Board's Order. For future filings in this matter, please keep in mind that NRC requirements indicate that all participants in the proceeding should be served with all documents filed in the proceeding in accordance with NRC regulations (10 C.F.R. 2.701 and 2.712), the Board's June 6, 2002, Initial Prehearing Order, and the Notice of Opportunity for Hearing published in the Federal Register on April 22, 2002 (67 Fed. Reg. 19,600). The most up-to-date service list is attached to the June 17, 2002, memo from the Secretary of the Commission to Chief Judge Bollwerk, a courtesy copy of which which was served by e-mail today.
