Proctor & Gamble web page, www.pg.com , did not provide locations or phone numbers. The PA Department of State Corporations and the Corporate Affiliations, Mergers and Acquisitions sites were searched, no information was obtained. Describe Communication with Registration Vendor: Industrial Dynamics, Michelle Alvorada, 1-888-434-5832 stated, during a telephone conversation on May 28, 2002 at 1 p.m., Vicks returned the sources for the FT-12 model. She explained, Vicks possessed two sources, not four.		
Vendor Follow-up Action: None		
Final Action Taken: Update NRC HQ's.		
Cause of Bad Address / Lesson Learned: The Vicks company was taken over by Proctor and Gamble. The Hatboro facility was shut down and Vicks returned all sources to the vender for disposal. The NRC was not notified.
