A copy of the June 24, 2002, Federal Register notice of final rulemaking, "Revision of Fee Schedules; Fee Recovery for FY 2002" is attached. The notice describes NRC's final amendments to the licensing, inspection and annual fees charged to its applicants and licensees. The final rule becomes effective August 23, 2002.

It is requested that OSTP notify the Agreement States to make distribution of the final rule to their licensees. The final rule, which will be effective on August 23, 2002, does not modify the fees currently assessed to those Agreement States licensees who perform work in Non-Agreement States under the reciprocity provisions of 10 CFR 150.20. The reciprocity fee remains at \$1,400.
