The changes to TS 3/4.3 affect actuation instrumentation for the following: Reactor Protection System, Emergency Core Cooling System, Control Rod Block System, Containment and Reactor Vessel Isolation System, Recirculation Pump Trip, Reactor Core Isolation Cooling Systems, and Plant Systems. In addition, several minor changes were required to correct apparent typographical errors included in the proposed TS.
