On September 20, 1974 you requested authorization to conduct certain activities pursuant to the provisions of 10 CFR Section 50.10(e)(1) of the Atomic Energy Commission's regulations. Our letter of October 21, 1974 authorized you to conduct those activities identified but did not include Item 5 of your request letter, pending further staff consideration. We have completed our review of these items and have concluded that all of Item 5, except those activities relating to the Turbine Room, Heater Bays, and Service Water Pumphouse, are authorized under 10 CFR Part 50.10(e)(1). Accordingly, you are authorized to conduct the following additional activities:
