Notice is hereby given that the United States Nuclear Regulatory Commission (Commission) is considering approval under Title 10 of the CODE OF FEDERAL REGULATIONS (CFR), Section 50.80, of the transfer of 12.58-percent ownership of the facilities for the Perry Nuclear Power Plant, Unit No. 1 (PNPP Unit 1) from the Ohio Edison Company (Ohio Edison) to a wholly owned subsidiary of Ohio Edison, OES Nuclear, Inc. (OES). By "Supplemental Application For License Transfer," submitted under cover of letter dated December 29, 1995, from Shaw, Pittman, Potts and Trowbridge, Ohio Edison informed the Commission that it intends to transfer to OES a 12.58-percent ownership interest in the PNPP Unit 1 "common facilities." This request supplements an earlier request to transfer a 17.42-percent ownership interest in PNPP Unit 1 from Ohio Edison to OES, which the NRC approved by Order dated December 20, 1995.
