NOTICE OF ISSUANCE OF PROVISIONAL CONSTRUCTION PERMIT

Notice is hereby given that, pursuant to the Initial Decision of the Atomic Safety and Licensing Board, dated July 18, 1967, the Director of the Division of Reactor Licensing has issued Provisional Construction Permit No. CPPR-32 to Wisconsin Michigan Power Company for the construction of a pressurized water nuclear reactor on the applicant's site which is located in the town of Two Creeks, Manitowoc County, Wisconsin. The reactor, known as the Point Beach Unit No. 1, is designed for initial operation at approximately 1396 thermal megawatts.

PROVISIONAL CONSTRUCTION PERMIT

Construction Permit No. CPPR-32

1. Pursuant to Section 104(b) of the Atomic Energy Act of 1954, as amended, (the Act) and Title 10, Chapter 1, Code of Federal Regulations, Part 50, "Licensing of Production and Utilization Facilities," and pursuant to the order of the Atomic Safety and Licensing Board, the Atomic Energy Commission (the Commission) hereby issues a provisional construction permit to Wisconsin Michigan Power Company (the applicant) for a utilization facility designed to operate at 1396 megawatts (thermal) (the facility), described in the application and amendments thereto filed in this matter by the applicant and in the evidence received at the public hearing upon that application. The facility, known as the Point Beach Unit No. 1, will be located at the applicant's site in the town of Two Creeks, Manitowoc County, Wisconsin.
2. This permit shall be deemed to contain and be subject to the conditions specified in Sections 50.54 and 50.55 of said regulations; is subject to all applicable provisions of the Act, and rules, regulations and orders of the Commission now or hereafter in effect; and is subject to the conditions specified or incorporated below:
 - A. The earliest date for the completion of the facility is January 1, 1970, and the latest date for completion of the facility is June 30, 1970.
 - B. The facility shall be constructed and located at the site as described in the application, as amended, in the town of Two Creeks, Manitowoc County, Wisconsin.
 - C. This construction permit authorizes the applicant to construct the facility described in the application and the hearing record in accordance with the principal architectural and engineering criteria set forth therein.
3. This permit is provisional to the extent that a license authorizing operation of the facility will not be issued by the Commission unless (a) the applicant submits to the Commission, by amendment to the application, the complete final safety analysis report, portions of which may be submitted and evaluated from time to time; (b) the Commission finds that the final

design provides reasonable assurance that the health and safety of the public will not be endangered by the operation of the facility in accordance with procedures approved by it in connection with the issuance of said license; and (c) the applicant submits proof of financial protection and the execution of an indemnity agreement as required by Section 170 of the Act.
