By letter dated February 19, 1973, you advised us of your interpretation of the Technical Specifications for Point Beach Units No. 1 and 2 relative to minimum staffing requirements. You expressed the opinion that the Technical Specifications as presently written would allow you to reduce your operating staff below the numbers listed in Figure 15.6.1-2 of the Technical Specifications. You also proposed a specific reduction in staffing requirements during a labor strike situation.

We have reviewed your letter and find that we cannot agree with your interpretation of staffing requirements. Specifically, it is the Commission's position that (1) Technical Specifications identify minimum requirements, and (2) there must be a minimum of one licensed reactor operator in the control room for each operating unit for all conditions other than cold shutdown.

To clarify the requirements of the Technical Specifications, we are hereby changing the Technical Specifications appended to License No. DPR-24 and No. DPR-27 as shown in Attachment A. We have concluded that this change, to clarify the minimum crew size requirements, does not present

a significant hazards consideration and that there is reasonable assurance that the health and safety of the public will not be endangered.

You may propose changes to the Technical Specifications relative to minimum crew size. You should, however, provide an adequate safety analysis to support any such proposed change.
