The purpose of this modification is to:

- (1) incorporate the position of Senior Security Analyst (Consultant) . As a result, Section Schedule A-1 YEAR 1 (BASE) of the Task Order is revised to reflect the new position with the associated hours as shown in Attachment 1 to this modification and EER Systems's proposal, dated 2/05/2002 with revisions dated 2/08/2002, and 2/13/2002;
- (2) revise Subsection B.8 CONSIDERATION AND OBLIGATION, by increasing the total estimated task order amount by \$163,144.71 from \$25,632,338.69 to \$25,795,483.40. This increase is associated with incorporating the position of Senior Security Analyst (Consultant) .
- (3) revise Section H SPECIAL CONTRACT REQUIREMENTS, by incorporating the position and functions of Senior Security Analyst (Consultant);
- (4) revise Subsection H.27 GOVERNMENT FURNISHED EQUIPMENT/PROPERTY (JUN 1988) by adding attachment number 36;"
- (5) revise Subsection J1 List of Attachments by adding attachment number 36 entitled "Government Furnished Property - Taft Street."

This modification confirms the NRC Contracting Officer's (CO) e-mail message provided to Ms. Joanne Newman of EER Systems on 2/11/02, in which Ms. Newman was notified of the CO's decision to authorize EER Systems to obtain the services of a Senior Security Analyst (Consultant) with a \$25,000 expenditure limit until the modification was executed.

(See attachment number 1 to this modification revised Schedule A-1.)

2. Under Subsection B.8 CONSIDERATION AND OBLIGATION, the first sentence of paragraph (b) is deleted entirely and the following is substituted in-lieu thereof:

"(a) The total estimated amount of this task order (ceiling) for the products/services ordered, delivered, and accepted under this task order is \$25,795,483.40."

3. Under Section H SPECIAL CONTRACT REQUIREMENTS, paragraph H.16.4.6.5 is incorporated as show below:

"H.16.4.6.5 Senior Security Analyst (Consultant)"

Functions: Performs expert level security analysis and associated development activities in support of all IT infrastructure and systems. Provides expertise and guidance on the development of security guidelines, policies and procedures on the Local and Wide Area Networks, including services for host and network based security solutions for all NRC systems. Expertise includes, but is not limited to, Cisco, Novell, Microsoft and UNIX environments, the NRC network and its interface with the Internet and other external access points.

Evaluates, installs, customizes and integrates commercial and custom security applications and hardware.

Provides expertise in preventing and responding to potential terrorist threats in the interest of ensuring public confidence.

Provides development and integration expertise in the area of three tier web architecture.

Designs and develops security "firewalls" between networks. This includes trusted and non-trusted network access points including the Internet .

Provides guidance in the operation and use of security applications throughout the NRC environment.

Provides fourth tier troubleshooting and problem resolution for Cisco, Novell, Microsoft and UNIX security environments. Provides expert guidance to staff in the security aspects of design, development and implementation.

Acts as liaison with the security community in order to obtain the most current security advisories and otherwise remain current on security matters and to keep the NRC security system current.

Performs the analysis and design of automated systems/subsystems requirements with particular emphasis on security matters such as encryption, verification and authentication.

Coordinates with the ISSO on security issues effecting the IT production operation environment.
