Gentlemen:

The Commission has issued the enclosed Amendments Nos. 33 and 37 to Facility Operating Licenses Nos. DPR-24 and DPR-27 for the Point Beach Nuclear Plant, Units Nos. 1 and 2. The amendments consist of changes to the Technical Specifications and are in accordance with NRC letter dated July 29, 1977.

These amendments delete Section 15.6.12, Respiratory Protection, of the Technical Specifications. Our letter to you dated July 29, 1977 has described the basis for these license amendments. The amendments are administrative changes in the licenses. You have concurred in this action by not presenting written objection as suggested in our July 29, 1977 letter.

We have evaluated the potential for environmental impact of plant operation in accordance with the enclosed amendments. Since the amendments apply to administrative details, we have determined that the amendments do not authorize a change in effluent types or total amounts nor an increase in power level, and will not result in any significant environmental impact. Having made this determination, we have further concluded that the amendments involve an action which is insignificant from the standpoint of environmental impact and pursuant to 10 CFR \$51.5(d)(4) that an environmental impact statement, negative declaration or environmental impact appraisal need not be prepared in connection with the issuance of these amendments.

The amendments do not involve significant new safety information of a type not considered by a previous Commission safety review of the facility. They do not involve a significant increase in the probability or consequences of an accident, do not involve a significant decrease in a safety margin, and therefore do not involve a significant hazards

# UNITED STATES NUCLEAR REGULATORY COMMISSION DOCKETS NOS. 50-266 AND 50-301 WISCONSIN ELECTRIC POWER COMPANY

The U. S. Nuclear Regulatory Commission (the Commission) has issued Amendments Nos. 33 and 37 to Facility Operating Licenses Nos. DPR-24 and DPR-27 issued to Wisconsin Electric Power Company, which revised Technical Specifications for operation of the Point Beach Nuclear Plant Units Nos. 1 and 2, located in the Town of Two Creeks, Manitowoc County, Wisconsin. The amendments are effective as of the date of issuance.

These amendments delete the Respiratory Protection Section of the Technical Specifications (15.6.12), which were superseded by changes to 10 CFR 20 Section 103(c) and (f).

The Commission has made appropriate findings as required by the Act and the Commission's rules and regulations in 10 CFR Chapter I, which are set forth in the license amendments. Prior public notice of these amendments was not required since the amendments do not involve a significant hazards consideration.

The Commission has determined that the issuance of these amendments will not result in any significant environmental impact and that pursuant to 10 CFR §51.5(d)(4) an environmental impact statement or negative declaration and enviornmental impact appraisal need not be prepared in connection with issuance of these amendments.
