The U.S. Nuclear Regulatory Commission (the Commission) is considering issuance of amendments to the licenses and Technical Specifications for the Point Beach Nuclear Plant, Unit Nos. 1 and 2, located in Manitowoc County, Wisconsin (Facility Operating License Nos. DPR-24 and DPR-27, respectively, issued to Wisconsin Electric Power Company, the licensee).

ENVIRONMENTAL ASSESSMENT

Identification of the Proposed Action:

The proposed action would reflect the change in the name of the licensee from Wisconsin Electric Power Company to Wisconsin Energy Company.

The proposed action is in accordance with the licensee's application for amendment of the facility operating license dated October 23, 1995.

The Need for the Proposed Action:

The proposed action is needed to properly reflect corporate administrative changes in the license and Technical Specifications.

Environmental Impacts of the Proposed Action:

The proposed action is administrative in nature only and will have no effect on the operation or maintenance of the facility whatsoever.

The change will not increase the probability or consequences of accidents, no changes are being made in the types of any effluents that may be released offsite, and there is no significant increase in the allowable individual or cumulative occupational radiation exposure. Accordingly, the Commission concludes that there are no significant radiological environmental impacts associated with the proposed action.

With regard to potential nonradiological impacts, the proposed action does not affect nonradiological plant effluents and has no other environmental impact. Accordingly, the Commission concludes that there are no significant nonradiological environmental impacts associated with the proposed action.

Alternatives to the Proposed Action:

Since the Commission has concluded there is no measurable environmental impact associated with the proposed action, any alternatives with equal or greater environmental impact need not be evaluated. As an alternative to the proposed action, the staff considered denial of the proposed action. Denial of the application would result in no change in current environmental impacts. The environmental impacts of the proposed action and the alternative action are similar.

Alternative Use of Resources:

This action does not involve the use of any resources not previously considered in the Final Environmental Statement for Point Beach.

Agencies and Persons Consulted:

In accordance with its stated policy, on March 11, 1996, the staff consulted with the Wisconsin State official, Ms. Sarah Jenkins, of the Public Service Commission of Wisconsin, regarding the environmental impact of the proposed action. The State official had no comments.
