By letter dated June 3, 2002, Transnuclear Inc. (TN) submitted Revision 3 of Application for Amendment No. 5 of Certificate of Compliance No. 1004 for the Standardized NUHOMS® System. The June 3, 2002, submittal contained proprietary and non-proprietary versions of the proposed changes to the Final Safety Analysis Report (FSAR) for the Standarized NUHOMS® System. The submittal also contained supporting ANSYS input files on electronic media for support of the revised thermal analysis. The non-proprietary version of the submittal has been made available electronically for public inspection in the U.S. Nuclear Regulatory Commission's (NRC) Public Document Room or from the Publicly Available Records (PARS) component of the NRC's Agencywide Documents Access and Management System (ADAMS). ADAMS is accessible from the NRC Web site at http://www.nrc.gov/reading-rm/adams.html (the Public Electronic Reading Room).

The information sought to be withheld from public disclosure by TN is listed below:

- 1. FSAR Appendix M, Revision 3 (Proprietary Version)
- 2. ANSYS Input Files (included on CD)

TN's letter included an affidavit executed by Robert M. Grenier, on June 3, 2002, that requested the above listed documents to be withheld from public disclosure pursuant to 10 CFR 2.790. The affidavit states that the submitted information should be withheld from public disclosure for the following reasons:

- (1) A similar product is manufactured and sold by competitors of TN, hence public disclosure of this information is likely to cause substantial harm to TN's competitive position.
- (2) Development of this information required a significant investment of labor and money. A competitor would have to undergo similar expense in order to generate equivalent information.
- (3) In order to acquire such information, a competitor would also require considerable time and inconvenience related to the development of a design and analysis of a dry spent fuel storage system.
- (4) The information consists of description of the design and analysis of a dry spent fuel

storage and transportation system, the application of which provides a competitive economic advantage. The availability of such information to competitors would enable them to modify their product to better compete with TN's products.

(5) In pricing TN's products and services, significant research, development, engineering, and other costs and expenses must be considered. The ability of TN's competitors to utilize such information without similar expenditure of resources may enable them to sell at prices reflecting significantly lower costs.

Based on your June 3, 2002, submittal, our review of the proprietary information listed, and the requirements of 10 CFR 2.790, we have determined that this information is proprietary commercial information and should be withheld from public disclosure pursuant to 10 CFR 2.790. It is the NRC's policy to achieve an effective balance between legitimate concerns for protection of competitive positions and the right of the public to be fully apprised of the basis for and effects of licensing and rulemaking actions.

If the need arises, we may send copies of this information to our consultants working in this area. We will, of course, ensure that the consultants have signed the appropriate agreements for handling proprietary information.

If the basis for withholding this information from public disclosure should change in the future such that the information could then be made available for public inspection, you should promptly notify the NRC. Please be advised that the NRC may have cause to review this determination in the future, for example, if the scope of a Freedom of Information Act request includes your withheld information. In all review situations, if the NRC makes a determination adverse to the above, you will be notified in advance of any public disclosure.
