SUBJECT: REQUEST FOR WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE

Dear Mr. Rickard:

By your application and affidavit dated May 29, 2002, you submitted a draft copy of the presentation material entitled, "CENTS Methodology Improvements Submittal," that would be used at a meeting with the Nuclear Regulatory Commission (NRC) staff and requested that it be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR) Section 2.790. A nonproprietary copy of this document was not provided for placement in the NRC's Public Document Room or added to the Agencywide Documents Access and Management System Public Electronic Reading Room.

The affidavit stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- a. A similar product is manufactured and sold by major competitors of WEC.
- b. WEC invested substantial funds and engineering resources in the development of this information. A competitors would have to undergo similar expense in generating equivalent information.
- c. The information consists of enhanced analysis methodologies for the design and evaluation of CE and <u>W</u> designed PWRs, the application of which provides a competitive economic advantage. The availability of such information to competitors would enable them to design their product to better compete with WEC, take marketing or other actions to improve their product's position or impair the position of WEC's product, and avoid developing similar technical analysis in support of their processes, methods or apparatus.
- d. In pricing WEC's products and services, significant research, development, engineering, analytical, manufacturing, licensing, quality assurance and other costs and expenses must be included. The ability of WEC's competitors to utilize such information without similar expenditure of resources may enable them to sell at prices reflecting significantly lower costs.
