Upon consideration of the July 19, 2002 supplemental intervention petition/hearing request of petitioners San Luis Obispo Mothers for Peace, et al., (collectively SLOMFP), it is the Licensing Board's perception that oral argument regarding standing and contention admissibility issues will require no more than two days.
