SUBJECT: MINUTES OF THE COMMITTEE TO REVIEW GENERIC
REQUIREMENTS MEETING NUMBER 374

The Committee To Review Generic Requirements (CRGR) held special Meeting No. 374 on June 25, 2002, from 3:00 P.M. to 5:00 P.M., with the attendees listed in Attachment 1. The purpose of this meeting was to review the proposed draft final amendment: Revision 10 CFR 50.55a (ADAMS Accession No. ML021570271) to incorporate by reference a later edition and addenda of the ASME Code.

Mr. Steve Tingen, Office of Nuclear Reactor Regulation, briefed the CRGR on the proposed rule to revise 10 CFR 50.55a. The slides for Mr. Tingen's presentation can be found in ADAMS, Accession No. ML021770198.

The CRGR asked questions and discussed various points of the proposed rule. Also, CRGR recommended that various text changes be made to better convey certain points of the rule. Furthermore, the CRGR indicated that three sections of the proposed rule are potential backfits and need to be further addressed by the staff. The following are the three points of backfit concerns, as referenced in Mr. Tingen's slides:

- 1) 50.55a(b)(2)(ix)(I) (Page 9 of slides)
- 2) 50.55a(b)(2)(xx) (Page 10 of slides)
- 3) 50.55a(b)(2)(xv)(A) (Page 10 of slides)

Finally, the CRGR and staff concurred that after modifications and further consideration of verbiage that implies a backfit, the revised rule would be sent to the CRGR for further review. After the CRGR members review the revised rule, a decision would be made for another formal review or to communicate to the staff that the revisions have adequately addressed CRGR concerns.
