Item 2: 10:30-12:00- Steve Tingen will discuss the staff's response addressing the CRGR backfit concerns (see CRGR Meeting Minutes #374, ML022050073) on the Final Draft Rule Revising 10 CFR 50.55a, "Codes and Standards."

Persons making presentations to the CRGR are responsible for (1) ensuring that the information required for CRGR review is provided to the committee (CRGR Charter Section IV); (2) coordinating and presenting views of other offices; (3) as appropriate, ensuring that other offices are represented during the presentation; (4) forwarding an electronic copy of the presentation materials to CRGR staff (L. Cupidon) as soon as possible before the meeting; (5) providing 10 copies of presentation materials for distribution on the day of the meeting; (6) and ensuring that agenda modifications are coordinated with the CRGR staff and others involved with the presentation. Sponsoring Division Directors or higher management should attend meetings addressing agenda items under their purview.
