AP-6.1Q, Rev 6, ICN 3 section 5.6.3.1 States the Responsible Individual [e.g. document owners] will "Notify DC and the new Responsible Individual, in writing, if for any reason the ownership of one or more documents requires change (e.g., reorganization, reassignment, termination)."

6. Description of Condition:
Contrary to the above requirement, the Manager of Special Projects did not notify document control when reassigned to another organization in January 2002, even though transfer of ownership of documents should have occurred. The annual document owners report for the Manager of Projects initiated 4/16/02 identified that 5 documents (B00000000-01717-4600-0078, TDR-PCS-SE-000001, TWP-MGR-SE-000001, TWP-PCS-SE-000001, and TDP-NBS-HS-000097) should have been transferred upon his reassignment.

In a discussion held 6/28/02, the Document Control Manager confirmed that her organization is typically not notified by document owners when they are reassigned and a change of ownership is required.
