In accordance with the Defense Authorization Amendments and Base Closure and Realignment Act of 1988 (Public Law 100-526), Jefferson Proving Ground (JPG) was closed on September 30, 1995. Due to this mandatory closure of JPG and as required by Nuclear Regulatory Commission (NRC) regulations found at Title 10 Code of Federal Regulations Part 20, the Army for JPG is required to terminate its NRC license for depleted uranium (DU).

As part of the U.S. Army's continuing efforts to keep the public and community informed about the activities at JPG concerning the termination of the NRC DU license and to provide an opportunity for the public and community to comment on documents related to this effort, please find enclosed for your information and review copies of the revised JPG DU License Termination Plan and the JPG Environmental Report.
