In Amendment #3 for the above referenced license, dated July 11, 2002 requested that Rio Algom notify of the closing of the sale transaction for the Smith Ranch Facility. As of July 22, 2002, that transaction has been completed with the transfer of the Wyoming DEQ Permit to Mine from Rio Algom Mining LLC (Rio Algom) to Power Resources, Inc. (PRi) The letter from the Wyoming DEQ approving the permit transfer is attached. With this transfer, the Wyoming DEQ has released Rio Algom's surety, CIBC Letter of Credit No. SBGT717209, with their replacement surety.


