1 Public Policy Advocates LLC ("PPA") submits its Cover Sheet Application (the  
2 "Application") for Allowance and Payment of Interim Compensation and Reimbursement of  
3 Expenses for the Period June 1, 2002 through June 30, 2002 (the "Application Period"). In  
4 support of the Application, PPA respectfully represents as follows:

5 1. PPA is the Legislative Activities Consultant to the Official Committee of  
6 Unsecured Creditors in the Pacific Gas and Electric Company ("Debtor") bankruptcy case. PPA  
7 hereby applies to the Court for allowance and payment of interim compensation for services  
8 rendered and reimbursement of expenses during the Application Period.

9 2. PPA billed a total of \$6,000.00 in fees and \$33.17 in expenses during the  
10 Application Period.

11 3. Accordingly, PPA seeks allowance of interim compensation in the total amount of  
12 \$5,133.17 at this time, which represents 85% of the fees for services rendered and 100% for  
13 expenses incurred.<sup>1</sup>

14 4. PPA has been paid a total of \$54,731.56 for fees and expenses to date.

15 5. To date (through 7/31/02) PPA is owed as follows (including amounts owed  
16 pursuant to this Application):

2 6. With regard to the copies of this Application served on counsel for the Debtor and  
3 the Office of the United States Trustee, attached as Exhibit 1 hereto is an invoice for the  
4 Application Period that complies with all Northern District of California Bankruptcy Local Rules  
5 and Compensation Guidelines and the Guidelines of the Office of the United States Trustee.

6 7. PPA has served a copy of this Application (without Exhibits) on the Special  
7 Notice List in this case.

8 8. Pursuant to this Court's "SECOND AMENDED ORDER ESTABLISHING  
9 INTERIM FEE APPLICATION AND EXPENSE REIMBURSEMENT PROCEDURE" which  
10 was entered on or about March 18, 2002, the Debtor is authorized to make the payment requested  
11 herein without a further hearing or order of this Court unless an objection to this Application is  
12 filed with the Court by the Debtor or the United States Trustee and served by the fifteenth day of  
13 the month following the service of this Application. If such an objection is filed, Debtor is  
14 authorized to pay the amounts, if any, not subject to the objection. This Cover Sheet Application  
15 was mailed by first class mail, postage prepaid, on or about July 31, 2002.

16 9. The interim compensation and reimbursement of expenses sought in this  
17 Application is on account and is not final. Upon the conclusion of this case, PPA will seek fees  
18 and reimbursement of the expenses incurred for the totality of the services rendered in the case.  
19 Any interim fees or reimbursement of expenses approved by this Court and received by PPA will  
20 be credited against such final fees and expenses as may be allowed by this Court.


21 10. PPA represents and warrants that its billing practices comply with all  
22 Northern District of California Bankruptcy Local Rules and Compensation Guidelines and the  
23 Guidelines of the Office of the United States Trustee. Neither PPA nor any members of PPA has
