

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.

CONTINUATION PAGE

The purpose of this modification is to allot funding for the Temporary Additional Services (TAS). The contract is hereby modified:

1. \$133,000 is hereby allotted to this contract for TAS. The first sentence of paragraphs(a)and(b) of Section B, Subsection B.4, CONSIDERATION AND OBLIGATION - DELIVER ORDERS, is deleted in its entirety and substituted with the following in lieu thereof:

"(a) The total estimated amount for the temporary additional services (TAS) ordered, delivered and accepted under this contract is \$867,366.

(b) The amount presently obligated with respect to this contract for TAS is \$859,241.75."

2. Section B, Subsection B.5, CONSIDERATION AND OBLIGATION FIRM FIXED PRICE, is deleted in its entirety and substituted with the following in lieu thereof:

"The firm fixed price for basic guard services under this contract is \$8,087,548.01. The total amount obligated under this contract, including TAS is \$8,946,789.76."
