

Accordingly, the following section of the contract is hereby modified:

Under Subsection **B.8 CONSIDERATION AND OBLIGATION**, the obligated amount is increased by \$134,724 from \$10,181,780.71 to \$10,316,504.71. Therefore, the first sentence of paragraph (b) is deleted entirely and the following is substituted in-lieu thereof:

"(b) The amount presently obligated with respect to this contract is \$10,316,504.71."
