expenses incurred during the Application Period.

2. The Firm billed a total of \$182,423.00 in fees and expenses during the Application Period. The total fees represent approximately 532.60 hours expended during the period covered by this Application. These fees and expenses break down as follows:

16 on or about July 31, 2002.


17 9. The interim compensation and reimbursement of expenses sought in this


