MB2937, MB2938, MB2944, MB2945, AND MB2939)

The purpose of this letter is to withdraw generic relief request GISI-1. TVA requested GISI-1 by letter dated September 14, 2001. TVA hereby withdraws Request for Relief GISI-1.

TVA recognizes that the proposed rulemaking to incorporate by reference certain ASME Edition and Addenda (66 FR 40626) into 10 CFR Part 50 impacts NRC's review of GISI-1. TVA may reconsider the subject proposal based upon the outcome of the final rule.
