In the referenced letter, Exelon Generation Company, LLC (Exelon) and AmerGen Energy Company, LLC (AmerGen), submitted a supplemental response for Interim Compensatory Measure (ICM) B.4.e to the NRC Order for Interim Safeguards and Security Compensatory Measures issued on February 25, 2002. In a August 12, 2002, telephone call between Mr. G. Dick of the NRC and Mr. P. Simpson of Exelon, the NRC provided feedback concerning the supplemental response. In response to that feedback, we have revised our supplemental response for ICM B.4.e and the attachment to this letter supercedes that provided in the referenced letter.

The attachment to this letter contains Safeguards Information. Therefore, it is requested that the attachment be withheld from public disclosure as Safeguards Information in accordance with 10 CFR 73.21, "Requirements for the Protection of Safeguards Information."




