-APPENDIX B

Describe Follow-up: (Telephone, Internet, Chamber of Commerce, etc.)

On June 15, 2000, John Pelchat, R-II, and Gary Purdy, NMSS, visited the general licensee's facility in Philippi, WV. Discussions with the General Manager indicated Philifilm, the original general licensee had declared bankruptcy and that the State of West Virginia, as the major creditor, took control of the its assets. The state subsequently sold the facility to the current owner.

The inspectors found that both GL devices (NDC model 103, serial no's. 11100 and 11101) were installed on a plastic extruder and were being used by the licensee. The devices contained 25 and 150 mCi of Am^{241} , respectively. The inspectors observed that the gauges were properly labeled and that the gauges appeared to be in good physical condition. The gauges were equipped with shutters and the shutters were found to be in the closed (shielded) position.

The General Manager stated that both devices routinely cared for as part of a preventative maintenance program provided by the extruder's vendor, Battenfeld Gloucester Engineering Company of Gloucester, MA. Maintenance records indicated that the collection of sealed source leak tests were part of the routine inspection procedure performed by the vendor. The General Manager added that he had observed vendor personnel collecting the leak test samples on occasion. The licensee had no records or other information regarding the results of leak test sample analysis. The licensee had no plans to discontinue use of the GL devices. The licensee possessed no other licensed materials.

The General Manager stated that the volunteer fire department had been made aware of the presences of the devices during routine tours of the facility.
