SUBJECT: EXEMPTION REQUEST

## EXEMPTION REQUEST QUESTIONS

1. Your letter of January 26, 1993, used two phrases to describe the IBEW members included in your exemption request - specifically:
  - a. certain clerical employees of PG&E, and
  - b. clerical employees at Diablo Canyon.

We understand this to mean that your request only encompasses IBEW Local 1245 members who are PG&E employees assigned to certain specific clerical jobs at the Diablo Canyon nuclear plant site. Conversely, we conclude the following are not included in the request:

- (1) persons who are not members of IBEW Local 1245
- (2) persons who are not employees of PG&E (i.e., contractors, vendors).

If this interpretation is in error, please correct our understanding of the intent of your request.

2. How would those persons to be exempted be selected, e.g., individually, by job, by job category, by task, or by some other criteria? How would the list of exempted persons be maintained (monitored, updated, etc.)?
3. Approximately how many persons at Diablo Canyon would be subject to the exemption? Is it anticipated that the number of persons will vary, and if so what is the range?
4. Are there non-union workers performing jobs or tasks similar to those for which an exemption is requested? If so, how many?
5. Are the normal workstations for persons who would be subject to the exemption located within the protected area? If so, specify where in the protected area these workstations are located.
6. Are there current measures that would enable security officers and other employees to readily identify persons exempted from random testing and authorized unescorted access to protected areas?
7. Are there access control measures that would restrict an exempted person's access to plant operating equipment (e.g., feedwater pumps, main condenser pumps, etc.) inside the protected area but located away from the exempted employee's normal workstation? Are there measures or features that could facilitate such control? If so, please describe.
