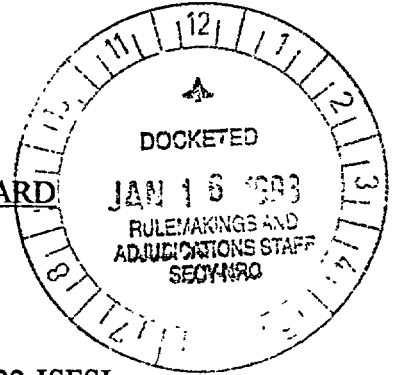

CLASSIFICATION OF CONTENTIONS ON BEHALF OF
THE CONFEDERATED TRIBES OF THE GOSHUTE RESERVATION
AND DAVID PETE

By Order dated January 6, 1998, the Board directed the Goshute Tribe to classify its contentions and to state whether it has any objections to the suggestions of PFS for redrafting those contentions. In response to that order the Goshute Tribe (and David Pete), by and through their counsel, John Paul Kennedy, 1385 Yale Avenue, Salt Lake City, Utah 84105, hereby submit the following:

Classification of Contentions:

- A. Decommissioning Plan Deficiencies. This contention potentially impacts safety, environmental, emergency planning, and may fall into the "other" category as well.
- B. Lack of protection against worst case accidents. This contention potentially impacts safety, environmental, emergency planning, and may fall into the "other" category as well.
- C. Inadequate Assessment of Costs under NEPA. This contention impacts environmental and "other" issues.

D. Inadequate Discussion of No-Action Alternative. This contention impacts environmental and “other” issues.

E. Failure to Give Adequate consideration to Adverse Impacts on the Historic District. This contention impacts environmental and “other” issues.

F. Failure to Adequately Establish Financial Qualifications. This contention potentially impacts safety, environmental, emergency planning, and may fall into the “other” category as well.

G. With respect to the contentions incorporated by reference, The Goshute Tribe hereby adopts and incorporates by reference the classifications designed by the initial proponents of those contentions. (Absence of NRC Authority, Non-Compliance with Regulations, Application for Permanent Repository, Inadequate Financial Qualifications, Regional and Cumulative Environmental Impacts, Statutory Authority, License Needed for Intermodal Transfer Facility.)


Proposed Redrafting by PFS:

Generally speaking, the Goshute Tribe objects to the redrafting of any of its contentions to the extent that such proposed redrafting would have the effect of narrowing the scope of those contentions. The Goshute Tribe asserts that the Application in this matter is in part broad and vague. Until all of the concerns regarding the scope and detail of the application have been fully resolved, the Goshute Tribe wishes to stand by its statements. To the extent, however, the proposed restatement of the contentions serves to provide additional clarity or any required

information or authority, the Goshute Tribe would accept such additions, again without limiting the scope of the contentions.

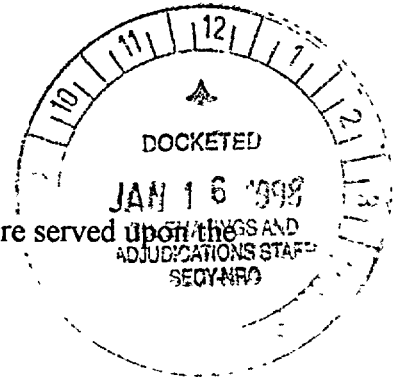


