SUBJECT: SUMMARY OF THE JULY 16, 2002, PUBLIC MEETINGS TO DISCUSS THE
IMC 0350 PROCESS AT DAVIS-BESSE

On July 16, 2002, the Nuclear Regulatory Commission (NRC) held two public meetings at the Oak Harbor High School in Oak Harbor, Ohio. The first meeting was between the NRC IMC 0350 Oversight Panel and FirstEnergy Nuclear Operating Company (FENOC) to discuss the licensee's restart plan for Davis-Besse Nuclear Power Station. The second meeting was between the NRC and members of the public. During the meeting, the NRC summarized the discussion from the earlier meeting between the NRC and FENOC.
